### 9/14/22 Faculty Senate Meeting Highlights

### Presentation by Diane Levin, University Ombuds

- The total numbers of visitors (faculty and staff) increased from 207 in 2018 to 428 this past fiscal year.
- The total number of visitor concerns increased from 335 in 2018 to 1076 this past fiscal year.
- Themes by all visitors include:
  - 1. Organizational and leadership
  - 2. Values, ethics, and standards
  - 3. Evaluative relationships
- In particular, faculty concerns include:
  - Low salaries
  - "One Northeastern" is not experienced by many NTT faculty
  - Throughout COVID, faculty did not feel supported by the administration with respect to the impact of childcare, having school-age children in K-12, etc.
  - o Faculty believe they have poor relationships with their unit heads
  - o Faculty concerned with staff retention
- Staff concerns include:
  - o Staff want reassurance from leadership
  - Many are worried about staff retention
  - o Bullying, microaggressions is a concern
  - Staff would like more education about compliance resources, yet they also distrust those resources
- Looking ahead:
  - Organizational climate: Employee retention concerns persist. Parking is a
    persistent problem and is a part of the whole compensation package
    considered not adequate vs competitors. Housing costs continue to be a
    significant issue.

- Employee experiences in evaluative relationships: ongoing pressures, supervisors need better preparation and accountability for their roles.

### <u>Presentation by Madeleine Estabrook, Senior Vice Chancellor, Student Affairs</u> Discussed summer pilot of Wellness Day program.

- 3 goals of program included:
  - 1. Self-care for students
  - 2. Efficient and private system of communication to faculty of student mental health
  - 3. University commitment to support student mental health
- Evaluation of program included survey with 160 students and 92 faculty who participated in program:
  - o Overall, students very supportive of program
  - o Faculty fairly neutral with no strong objections
- Future plans include a possible pilot during the fall semester; full communication to all faculty and staff with program information and guidelines will soon be distributed.






### Message from the Sr. Vice Provost and Executive Vice Provost for Academic Affairs:
