

SAC Report to Northeastern Senior Leadership

On October 12, 2023, the Senate Agenda Committee (SAC) convened with the Senior Leadership of Northeastern to introduce the SAC members for the academic year 2023-24 and to delineate the SAC Priority Areas for the year.

The major areas of priority are as follows:

- Enhancing Communication between Faculty and Administration
- Expanding Faculty Opportunities across the NU Global Network
- Defining and implementing the 'NU One Faculty' Model
- Ensuring Technology Access within and across the NU Global Network
- Addressing Issues Pertaining to Faculty Salary Equity

Active Faculty Concerns

Childcare costs are on the rise and faculty need additional support – we are asking HR to review comparable practices and continue to advocate for faculty.

Tuition waiver for the FlexJD program in the law school is not extended to full time faculty. HR is reviewing the benefit package to see what is covered and the SAC is following up to get a timely response for spring applications. In addition, SAC has also raised tuition exchange programs with other institutions.

Spring academic calendar is short on Monday class meetings due to holidays. While we cannot change the schedule for Spring 2024, we have referred this issue to the registrar to investigate solutions.
